The following document sets out the Terms and Conditions by which Destiny School Of Dance Ltd agrees to provide services.

By participating in our classes, you are agreeing to these Terms and Conditions.

It is your responsibility to familiarise yourself with them before you or your child participates in any activity with us. We reserve the right to modify, cancel or amend these Terms and Conditions and upon doing so shall provide you with notification that there has been a change.

The current Terms and Conditions always appear on our website.

On purchase of any product or service, the most recent Terms and Conditions shall apply

FEES AND PAYMENTS

- Payments for subscription classes are due on the 1st of the month for the month ahead
- Non-subscription classes must be booked at least 2 weeks prior to the class date (Payments will be returned if a class has to be cancelled due to minimum numbers not being achieved)
- Destiny School Of Dance Ltd only accept card payments for classes through the Class 4 Kids system
- Your booking is not confirmed until payment has been received by Destiny School Of Dance Ltd
- All classes are payable. Destiny School Of Dance Ltd do not issue refunds for missed sessions due to your own circumstances
- If there are any classes cancelled by Destiny School Of Dance Ltd for bad weather or staff illness, Destiny School Of Dance Ltd will offer a free class or if this is not possible, Parents will be refunded
- If a pupil enrols after the start of the month a pro-rata charge will apply for the first month
- Students will now have access to classes if Parents fees have not been initially collected
- Students will be suspended from class if fees are not collected by the final attempt via Class 4 Kids
- We reserve the right to suspend participation in lessons until any overdue payments have been made
- A minimum of three weeks notice should be given in writing for withdrawal from classes. Failure to do so correctly will result in any outstanding fees still being owed
- In the event of a long term absence through injury or other reasons, please discuss with the principal who will consider each case on an individual basis
- Any monies paid to Destiny School Of Dance Ltd for uniform before issuing a withdrawal notice will be lost if the uniform has already been ordered

TRIAL LESSONS

- Destiny School Of Dance Ltd offers a free trial lesson to all new pupils, (weekly classes + SEN only) providing there is availability in the appropriate class
- Following a trial lesson an invoice will be issued for the remaining lessons in the month. This must be paid before the first lesson following the trial
- Parents and Guardians must initially complete registration through Class 4 Kids to sign up for a free trial class
- If a child is unable to make the arranged trial lesson, a further free trial may be arranged at our discretion
- Returning pupils are not eligible for a free trial lesson before re-joining the same class they withdrew from
- Returning and current pupils are eligible for a free trial class if they are joining a new class

CLASSES

- All Children under 18 years of age who wish to join Destiny School Of Dance Ltd must be accompanied by an adult/guardian
- Parents are not permitted to watch classes each week but can view their child's trial class on their first day
- A waiting room will be provided for parents and guardians to wait during class times where possible, depending on the venue
- Students are encouraged to enrol in an adult class from age 17+
- Subscription classes are not charged per class but instead a monthly subscription charge irrespective of how many classes are delivered within that month
- Classes are only delivered during term time. Any dance camps or workshops delivered during the school holiday's will be charged at an extra fee and will not be covered by subscription fees
- Destiny School of Dance Ltd students will be entitled to discounted camps/workshops during school holiday's
- We will no longer have observation classes for Parents. Instead, Parents will be invited to an annual end of year showcase
- Students who need personal care assistance must be taken to the bathroom before their class begins to limit class disruptions
- Students should aim to arrive on site at least 15 minutes before their class start time to ensure a punctual arrival into class
- Chewing gum or eating will not be accepted in the dance studio
- Please provide your child with a drink in a water bottle for their classes. Cartons and cans are not suitable
- Private lessons are available for extra dance tuition. Parents are welcome to stay and watch private lessons
- It is not compulsory for students to attend recreational classes in branded school uniform

PERFORMANCE CLASS

- Aspiring Performance class students are required to attend an initial class treated as an audition
- Following the audition process, an email will be sent to inform both student and Parents of the result
- Performing students must attend a training class at Destiny School of Dance Ltd in addition to the performance class
- Performing students must be 100% committed to this additional class
- Performing students will be expected to be available for all performances, competitions and other opportunities that arise
- Performing students will work on a strike system. Three strikes at any time during a 12 month period will result in that student losing their place in Team Destiny
- Strikes include absence, lateness to any classes, rude behaviour, breaking school rules i.e. chewing in class etc
- Performance students must have FULL school branded uniform to participate in any performing work

STUDENT ABSENCES

- Please notify Destiny School Of Dance Ltd of all absences and all holiday's booked as soon as possible. This helps us to be aware of class numbers and who we are expecting
- In the event of sickness, please give at least 48 hours notice by telephone or email. Please do not use social media to notify us as notifications can easily be missed
- Fees are non refundable for absent students
- If a student is away from class for more than 3 weeks without notification, Destiny School Of Dance Ltd have the right to remove the student off the class register

CANCELLATION OF CLASSES

- Occasionally it is necessary to cancel or change the time/venue of a class. Should this ever have to occur, Destiny School Of
 Dance Ltd will notify Parents and Guardians immediately by email and our social media
- We reserve the right to cancel any classes anytime up to and including the date the class starts. Should this occur we will endeavour to give you as much notice as possible and the lesson either rescheduled or carried over to the following month

HEALTH AND INJURY

- Pupils participate at their own risk and Parents and Guardians are obliged to inform Destiny School Of Dance Ltd of any existing injuries or medical conditions.
- Destiny School Of Dance Ltd must be informed immediately of any changes to a pupils health record
- Pupils must wear suitable footwear and clothing at all times. New pupils will have a grace period of 1 month to settle in to classes after which it is expected that the correct footwear is purchased for use in class
- Destiny School Of Dance Ltd uniform is currently optional in our classes, however clothing must still be appropriate for dancing
- No restrictive or indecent clothing will be permitted in class
- If a pupil is unwell or has an accident during class time, the incident will be logged in our accident book and if necessary, the emergency contacts will be called via the contact details provided on registration
- It is the responsibility of Parents and Guardians to ensure that their contact information is correct and up to date
- Should First Aid treatment be required, treatment will be administered by our on-site first aider
- The administering of any medication e.g. epi pens or complex medical conditions must be discussed with the principal prior to attending any sessions

PERSONAL PROPERTY

- Pupils are obliged to take care of their own belongings
- All personal items including shoes should be labelled with the pupil's name
- Please refrain from bringing any items of value to class
- Destiny School Of Dance Ltd do not accept responsibility for any personal property that is lost or damaged
